**Declaration by an event participant  
in connection with the state of COVID-19 epidemic**

*The Dramatic Theatre of the capital city of Warsaw, hereinafter called the Theatre, would like to ask you to complete this declaration in connection with your attendance at an event held at the Theatre in order to protect your and other participants' health. Your data will be safeguarded in compliance with the GDPR and used only to protect public health.*

*You will be allowed to attend the event only if you complete the declaration.*

1. I declare that, to the best of my knowledge, within the last 14 days before making this declaration:

- a. I have not been found to be infected with the SARS-CoV-2 virus;
- b. I have not been subject to obligatory quarantine or epidemiological supervision due to a suspected infection with the SARS-CoV-2 virus;
- c. I have not come into a direct contact with persons affected with the circumstances specified in points (a) and (b) above;
- d. I have not experienced any of the following symptoms: fever, cough, shortness of breath, muscle pains, impaired smell and taste, excessive tiredness.

2. In the event that I experience COVID-19 infection symptoms within 14 days of my attendance at the event held at the Theatre, I undertake to immediately notify competent local sanitary and epidemiological services and the Theatre's health issues coordinator at the following e-mail: [anna.cis@teatrdramatyczny.pl](mailto:anna.cis@teatrdramatyczny.pl)

3. I undertake to comply with the **Safety rules for event participants in connection with the state of COVID-19 epidemic** which apply at the Theatre.

In addition:

I agree to have my personal data included in this declaration stored in the Theatre's personal data file to be accessible upon request of competent sanitary services to the extent necessary for epidemiological investigation in the event that I become infected / I am found to have come into a direct contact with an infected person in accordance with the applicable regulations on preventing, counteracting and combatting the SARS-CoV-2 (COVID-19).

I declare that I have been informed, in accordance with Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation), about the following:

- 1) The Theatre is the data controller for my personal data.
- 2) The basis for processing personal data is Article 9(2)(i) and Article 6(1)(a) of the GDPR, i.e. processing necessary for reasons of public interest in the area of public health, along with the person's consent;
- 3) The Theatre's compliance with the principles of personal data protection is supervised by the Data Protection Officer who can be contacted at [iod@teatrdramatyczny.pl](mailto:iod@teatrdramatyczny.pl) or by post at the Theatre's address;
- 4) I have the right to request access to my personal data, to rectify them, to erase them or to restrict their processing, the right to object to their processing, and the right to transfer the data;
- 5) In the event that I become aware that my personal data are processed unlawfully, I will have the right to file a complaint with the supervisory authority competent for personal data protection matters;
- 6) The data will be processed by the Theatre for a period of 2 weeks from the date of making this declaration.
